2017 has seen several regulatory changes_in maritime law in New Zealand, a number of interesting international cases covering carriage of goods, freight forwarders liability, and charterparty issues, the rapid development in blockchain technology and cybersecurity issues.

Maritime Law

Regulatory Developments

Biofouling: In advance of the new Craft Risk Management Standard on Biofouling (coming in to force on 1 May 2018), MPI has responded in several instances of biofouling present on vessels entering New Zealand in 2017. Of particular note was the MV DL Marigold which was ordered out of New Zealand part way through discharge, and subsequently denied entry into other Pacific ports, forcing hull cleaning in international waters. Ballast Water: On 8 September 2017, new regulations came into force for commercial and recreational vessels that undertake international voyages and carry non-permanent ballast water. A vessel is now required to either treat or exchange its ballast water and have a ballast water management plan to avoid introducing harmful aquatic organisms into New Zealand's marine environment. Cartels Amendment Act 2017: The primary purpose of the new Act is to introduce criminal sanctions for serious cartel behaviour (and other changes to jurisdiction and penalties). Cartel behaviour is an agreement or association between two or more business houses for, amongst other things, regulating output and fixing prices. The Act also introduces a new targeted exception for specified international liner shipping activities, such as vessel sharing, that improve the services supplied to importers and exporters. Health and Safety: The proposed Maritime Transport Amendment Bill 2016 seeks, among other things, to manage the risks associated with alcohol and drug use in the commercial maritime sector by requiring maritime operators to have drug and alcohol management plans.
